This Ballot will take place between 5<sup>th</sup> and 13<sup>th</sup> July 2018.

Directors continuing on the Board are Neil Padden, Greg Young, John McCuaig and Philip Clinton.

All other nominations are received and meet the required number of vacancies and are therefore confirmed elected and unopposed.

Under the new Constitution, the Board has requested that the election process be conducted electronically by TrueVote in 2018 and members will receive voting papers via email within the required time. All eligible members are encouraged to complete the vote on-line or if assistance is needed, can be done in the Club's administration office on one of the computers.

The Secretary shall report in writing the result of the ballot to the Chairman of the Annual General Meeting who shall declare same at the meeting. The Chairman shall read the report and shall declare the candidates who the report states as having the greatest number of votes as the candidates elected to office. If two or more candidates obtain an equal number of votes the position shall be decided by vote at the Annual General Meeting on a show of hands and in the case of an equality of votes the Chairman shall have a second or casting vote.
